SUBJECT: Request for Release of Commercialized Intellectual Property

Jeanine Judd and Beverly Anne Richardson, both employed as teachers by Culpeper County Public Schools, have informed me of their intent to develop instructional materials designed to teach elementary students how to communicate and collaborate effectively. Board members may remember the last report from Farmington Elementary School included information about the Table Talk project.

Policy GCQB states that employees are to notify the superintendent of plans to develop copyright materials *to resolve any confusion or dispute over ownership rights to such materials*. Regulation GCQB-R1 states that materials developed within the scope of employment **could** be considered property of Culpeper County Public Schools. I am recommending that the Culpeper County School Board waive any ownership claims to Table Talk. I have discussed this matter with members of the Administration Committee and received their consensus to support this recommendation before the full Board.
